O R D E R

(1) IN RE: ISSUE OF ON BOARD DIAGNOSTIC

Report No.99 submitted by the EPCA on 26.07.2019. Pursuant thereto an affidavit on behalf of Ministry of Road Transport and Highways has been handed over in Court, in compliance thereof. The aforesaid affidavit is taken on record. Since the matter pertains to the pollution problem of Delhi, as stated in the affidavit, to finalize the matters the proposed time lines with respect to the receipt of the recommendation of AIS panel from the date of constitution of committee is reduced from four months to two months. And for review and recommendation of suitable panel on

Augmentation of facility of I/M from the date of recommendations of AIS panel is reduced from six months to four months.

Mr. Chirag M. Shroff, learned counsel, filed an affidavit on behalf of GNCT (Transport Department). We have considered the said affidavit. The objections raised are found to be baseless.

Let the Ministry of Road Transport and Highways (MoRTH) as well as Ministry of Law take the final decision within the time fixed by this Court and inform this Court.
